"Celebrating Businesses of Freedom 1880-1920": *The Towle Building*

Elias Towle constructed side-by-side buildings between the village square and the western edge of the millpond in 1845, where he operated a successful general mercantile store. At the age of twenty-one Elias Irving Towle acquired the general store from his father. In 1879 he formed the business partnership of E. I. Towle & Co. with George I. Philbrick, a young clerk at the store.

The Towle buildings were the center of commercial life in Freedom. At various times during the 1880-1920 era, businesses housed there included:

- The harness shop of C. E. and A. Moulton
- The medical office of Drs. Calvin Topliff, A. D. Merrow and Geo. W. Lougee
- An apothecary shop started by Dr.
 Merrow and later operated by Dr.
 Lougee

- The Ossipee Valley Ten Cents Saving
 Bank
- The clothing manufacturing operation of E. I. Towle & Co.
- An undertaker (successively J. A. Bennett, D. P. Cutting and W. A. Bennett)
- A tailor shop operated by Alonzo Pease
- A barber shop and ice cream parlor run by C. S. McAlister
- The Freedom Post Office
- Social organizations such as the Grange, Odd Fellows & Rebekahs

E.I. Towle Building 1845-1945

The Towle Building, built by Elias Towle and taken over by his son, Elias Irving Towle, was almost like a 'Mini-mall' of its day. It housed several businesses and was a gathering place for social organizations. Described below is a sample of some of the businesses.



Clothing Manufacturing

E. I. Towle & Company, a partnership between E. I. Towle and George I. Philbrick, began manufacturing men's clothing in 1880. Boston clothing firms cut the material and shipped the pieces to Freedom where they were sewn together in the small factory space to the left of their general store. Over 40,000 pairs of men's work pants were completed annually and shipped back to Boston to be sold in retail stores.




Advertisement for E. I. Towle & Company, from the 1903 Old Home Week program.

Ossipee Valley Ten Cent Savings Bank

The Bank was chartered in 1868 by Josiah Thurston, Elias Towle, John Demeritt, Ransellear Towle, John Parsons, John L. Demeritt, Stephen J. Keneson, and William Harmon.. The bank opened for business in Elias Towle's building on August 31, 1868. By 1893 its deposits peaked at \$139,575 (~ \$4.5MM today).

However, a court-ordered liquidation began October 1, 1901, and by May 11, 1905 the liquidation of assets was completed. The payout to depositors was 74% of their pre-liquidation balance.




Annual bank receipts 1868-1905, Ossipee Valley Ten Cents Savings Bank

Medical Practices

As early as 1860 the E. I. Towle & Company building housed the medical practice of the town's first physician. His office was later occupied by his son-in-law, Dr. Augustus Davis Merrow, a Bowdoin-trained physician who moved to Freedom in 1867 and practiced here until his death in 1900. A prominent member of his profession, Dr. Merrow served for a time as President of the Carroll County Medical Society. In 1886 he opened an apothecary shop in the Towle building with his son, Edward. This establishment provided area residents with medicine and medical supplies.




Dr. Augustus D. Merrow

Dr. Merrow was succeeded by his son-in-law, Dr. George Woodworth Lougee, who also operated the apothecary after Edward Merrow died in 1901. Both a physician and surgeon, Dr. Lougee graduated from the Bowdoin Medical School in 1883. He was a member of the New Hampshire Medical Society, served as the Coroner for Carroll County, and was even the local agent for the Travelers Insurance Company in the early 1890s.

Tailor Shop

Alonzo Pease operated a tailoring business on the second floor of E. I. Towle & Company's building. His sign is visible in the photo of the building's exterior seen in the photo below.



"Buy Local" encouragement from E. I. Towle & Co., circa 1904



The Traveling Post Office


The Freedom Post Office was located in the Towle building throughout the latter half of the 1800s, and all of the Postmasters in that era had a connection to the Towle family. Ransellaer Towle (cousin of E. I. Towle) held the position from 1862 to 1885. George I. Philbrick (business partner of E. I. Towle) was appointed in 1886 and held the position until 1890. Frank Towle (son of Ransellaer Towle) was appointed in 1891 and held the position until 1894. George I. Philbrick was appointed again in 1895 and held the position for two more years.

In 1897 Lillian B. Merrow secured the Postmaster appointment with assistance from her older brother, Frank Black, who just happened to be the Governor of New York and a summer resident of Freedom. She then moved the Post Office across the square to the ell of the building that housed Frank and Mary Ferren's stores, now the Federal House (hence its name that is carried on to today).



Business announcement by W. A. Bennett, from the 1902 Annual Report of the Town of Freedom. (Bennett printed the town's Annual Reports for many years)


Barber Shop

Telephone Service

The first public telephone in Freedom was installed at the E. I. Towle & Co. general store by 1901. In those days, a conversation made through the Bell System's long-distance service must have seemed both miraculous and exorbitantly expensive. Interested in how early telephones worked?
